

# EQUIPMENT RENTAL AGREEMENT

1. SUBJECT OF AGREEMENT. Producer and Production Company hereby engages SLIK for the leasing of certain Lighting Equipment to be provided for the Project.

2. LEASE OF EQUIPMENT. SLIK shall lease to Producer and Production Company, certain Lighting Equipment ("The Equipment") consisting of those items described and enumerated in the accompanying Exhibit "A" to the Agreement, as set forth below. SLIK hereby warrants that the Equipment is adequate for the Project, and is of durable and suitable quality for the Project.

3. TERM OF AGREEMENT. SLIK will provide the Equipment pursuant to the Agreement commencing on \_\_\_\_\_, 2016, and will continue through the completion of the Project, or until the Agreement is terminated as set forth herein.

4. COMPENSATION. SLIK shall receive \_\_\_\_\_ as compensation for its lease of any and all equipment provided. Such compensation shall be paid upon Producer and Production Company's receipt of invoice from SLIK.

5. REIMBURSEMENT OF EXPENSES. During the term of the Agreement, SLIK shall bill and Producer and Production Company shall reimburse it for all reasonable and approved out-of-pocket expenses, which are incurred in connection with the performance of the duties hereunder.

6. INDEMNIFICATION. Producer and Production Company agrees to defend, indemnify and hold SLIK harmless from any and all claims in connection with the Equipment, as a result of their maintenance or possession of the Equipment from the time it leaves SLIK's place of business until it is returned to SLIK.

7. LOSS OR DAMAGE TO THE EQUIPMENT. Producer and Production Company shall be responsible for any and all loss, damage or destruction of the Equipment during the performance of this Agreement, and shall maintain all risk perils property insurance covering the Equipment sufficient to cover the Equipment at its replacement value.

8. INSURANCE PROTECTION. Producer and Production Company shall maintain Workers' Compensation Insurance, with minimum limits of \$1,000,000 and general Liability Insurance providing aggregate limits of not less than \$2,000,000 and not less than \$1,000,00 per occurrence.

9. PRODUCER AND PRODUCTION COMPANY LIABILITY. Producer and Production Company assumes all obligation and liability with respect to the possession of the Equipment, and for its use, condition and storage throughout the term of the Agreement.

10. RETURN OF EQUIPMENT. Upon expiration of the Agreement, Producer and Production Company will return the Equipment to SLIK, free from all damage and in the same condition and appearance as when received.

11. CONFIDENTIALITY. SLIK agrees to maintain the confidential nature of any and all matters relating to the Project and not at any time to take any unauthorized photographs, nor video, by any and all electronic or mechanical means, nor audio recording, by any and all electronic or mechanical means, nor to pass on nor to release to any person any information, photographs, videos, nor audio recordings nor things coming into her/his/their possession which relate to the Project.

12. SLIK represents that it is free to enter into the Agreement, and that the Agreement does not violate the terms of any Agreement between SLIK and any third party

13. TERMINATION OF AGREEMENT. Any party to the Agreement may terminate the Agreement at any time by \_\_\_\_\_ working days' written notice to the other parties.

14. GOVERNING LAW. The terms and conditions of this Agreement shall be interpreted and governed by the law of the State of California and is subject to the jurisdiction of the Superior Court of the County of Los Angeles.

15. SEVERABILITY. If any provision of the Agreement is held invalid or unenforceable, the remainder of the Agreement will remain in full force and effect.

16. ENTIRE AGREEMENT. This Agreement contains the entire understanding of the parties, and may be changed or modified only by further written agreement duly executed by the parties. No amendment, nor change, nor modification of this Agreement in any manner whatsoever shall be valid unless in writing and signed by all parties.
